

IN THE MATTER OF DOCUMENTING THE RECEIPT OF BIDS FOR THE SPENCER #2 DITCH PROJECT; AWARDING THE CONTRACT TO CY SCHWIETERMAN, INC..

RESOLUTION

WHEREAS, on February 25, 2010, Resolution #10-073 the Board of County Commissioners set March 30, 2010 as the date to receive bids for the Spencer #2 Ditch project; and,

WHEREAS, those present for the bid opening with the Commissioners were Co. Engineer Doug Reinhart and Asst. Co. Engineer Kevin Schnell; and,

WHEREAS, two (2) bids were received for this project; same being:

Cy Schwieterman, Inc.	\$41,917.00
J & M Excavating	\$42,587.85
Engineer's Estimate -----	\$46,903.50

and,

WHEREAS, bids were given to the County Engineer personnel for review and comparison and upon review of the bids, as received, the County Engineer recommended the award be presented to Cy Schwieterman, Inc. for the Spencer #2 Ditch project as its bid is a good and complete bid.

THEREFORE, BE IT RESOLVED that the Board of County Commissioners, Auglaize County, Ohio, does hereby award the bid for the construction of Spencer #2 Ditch project to Cy Schwieterman, Inc. in the amount of \$41,917.00; and,

BE IT FURTHER RESOLVED that the County Engineer is hereby directed to prepare the contract and bond and, having secured the signatures of said bidder and its surety, present the same to the Board of County Commissioners for approval and execution; and,

BE IT STILL FURTHER RESOLVED that the whole of such work shall be completed and all material furnished by December 31, 2010, provided that the time of furnishing such material and completing such labor shall correspond with the time provided for its use in the progress of the work.
