NOTICE OF SECOND PUBLIC HEARING FY 2008 Community Development Block Grant Formula Program

The Auglaize Board of County Commissioners of Auglaize County, Ohio intends to apply to the Ohio Department of Development (ODOD) for funding under the Community Development Block Grant (CDBG) Small Cities Community Development Program, a federal program administered by the State.
