A preliminary field survey for the Harruff Single county Ditch has been completed. Based upon the wishes of the landowner where much of the improvement exists, designing the construction of said Harruff tile ditch with waterway, and not disturbing the petitioners yard area and existing trees is quite challenging. More time is necessary to complete the plans and specifications to the satisfaction of the landowners and still solve the prayer of the petition.

The Board will be notified when the plans, specifications and schedule of assessments are complete for the Harruff Single County Ditch and at such time, the final hearing can be scheduled.
