**WHEREAS**, the Auglaize County Department of Job and Family Services has the responsibility of contracting with various agencies for placement and related services for children who are in the care and custody of said Department, as well as, the protective services for dependent, neglected and abused children; and,

**WHEREAS**, on January 3, 2013, Resolution #13-009 a contract for said professional services, between the Auglaize County Department of Job and Family Services, a Title IV-E Agency, and the Marsh Foundation was provided to the Board of County Commissioners by the Job & Family Services Dept. with a request that the Board approve the contract with the term of contract being January 1, 2013 through December 31, 2013 at the maximum cost of \$31,025.00 for contracted services; and,

**WHEREAS**, on January 29, 2013, our agency placed an additional child with the Marsh Foundation. The Board will need to amend the current contract amount to reflect this additional per diem – the contract needs to be increased by \$21,200.00 for a maximum cost of \$52,225.00.

**THEREFORE, BE IT RESOLVED** that the Board of Commissioners, Auglaize County, Ohio does hereby approve the amendment in the contract of \$21,200.00 between Auglaize County Department of Job and Family Services and the Marsh Foundation for the professional services to dependent, neglected and abused children in the custody and care of the Job & Family Services Dept.; and,

CONCERNING A REQUEST FOR A ROAD NAME CHANGE IN WAYNE TOWNSHIP.**

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 14th day of February, 2013.

Commissioner Bergman moved the adoption of the following:

**RESOLUTION**

**WHEREAS**, on February 12, 2013, County Engineer Doug Reinhart met with the Board of County Commissioners, presenting the Board with a petition signed by county property owners living on Hiett Road, in Wayne Township is located between Fairmont Road and May Road, is 2 1/2 miles in length and runs through and into sections 15, 22 & 27 Wayne Township; said petition was submitted to Engineer Reinhart by the Ron Pepple on behalf of the petitioners; and,

**WHEREAS**, petition document reads: "Hiett Road Name Petition the following residents residing on (Hiett – Heit – Hyatt – etc.) Road, Wayne Township, Auglaize County are requesting the Commissioners act to standardize the Road Name to that of its most recent namesake "Hiett" and to further take the necessary actions to notify all appropriated agencies of the name standardization to insure Census, fiscal and governmental records are aligned and accurate. Currently this road is a North/South road that extends between Fairmont and May Roads for approximately 2 miles and has 11 residences established of which 9 are currently occupied. Signed by J. Ronald Pepple & Marcia L. Pepple, 16435 Hiett Road; David Chiles and Darlene Chiles, 16196 Hiett Road; Tom Brookhart and Heidi Brookhart, 16631 Hiett Road; David Zimmerman and Renee Zimmerman, 16731 Hiett Road; Samuel L. Wireman and April Wireman, 17104 Hiett Road; William M. Hawkins and William Hawkins Jr., 17603 Hiett Road; Kelly Snay and F. Ivan Snay, 17993 Hiett Road; and,

**WHEREAS**, Engineer Reinhart supports this petition and road name change, informing the Board over the past century, the spelling of the name has been in question. Between the current county map, numerous county Atlas, landowner names in the past, etc., the name has been spelled Hiett, Heit, Heitt and Hyatt. This has created confusion to landowners, mail carriers, delivery services, mailing addresses used by the County Auditor/Treasurer, etc., and,

**WHEREAS**, attached is a petition signed by 14 landowners who currently reside on that roadway, asking the Board of County Commissioners to officially adopt "Hiett" as the name of the roadway; and,

**WHEREAS**, pursuant to Ohio Revised Code Section 5541.04, the Board of County Commissioners is to hold a public hearing concerning this request for a road name change before a decision can be made on this petition.

**THEREFORE, BE IT RESOLVED** that the Board of County Commissioners, Auglaize County, Ohio does hereby set March 14, 2013, at 2:00 p.m. as the date and time to hold a public hearing in its office in the Auglaize County Administration Building, 209 S. Blackhoof Street, concerning the petition to have the name of Hiett, Heit, Heitt and Hyatt Road, in Wayne Township, changed to **Hiett Road**.
