

**IN THE MATTER OF REORGANIZATION OF THE BOARD OF AUGLAIZE COUNTY COMMISSIONERS  
FOR THE YEAR 2017.**

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 9th day of January, 2017.

Commissioner Regula moved the adoption of the following:  
**RESOLUTION**

**WHEREAS**, Section 305.05 of the Ohio Revised Code states that the Board of County Commissioners shall organize on the second Monday of January of each year; and,

**WHEREAS**, on Monday, January 9, 2017, at 8:50 a.m., President of the Board Don Regula turned the meeting over to Esther Leffel as Clerk of the Board for the reorganization of the Board of County Commissioners of Auglaize County, Ohio; and,

**WHEREAS**, Clerk Leffel, asked for a motion for nominations for the President of the Board and Vice President of said Board for 2017; Commissioner Regula made the motion that John N. Bergman to serve as President of the Board and Douglas A. Spencer to serve as Vice President of said Board for 2017 and Commissioner Spencer seconded the motion. Roll call vote was taken on this motion; Mr. Regula - yes; Mr. Bergman - yes; Mr. Spencer - yes. Motion carried.

**THEREFORE BE IT RESOLVED** that the Board of County Commissioners of Auglaize County, Ohio, does hereby reorganize for the year of 2017, naming John N. Bergman to serve as President of the Board; Douglas A. Spencer will serve as Vice President; Don Regula will serve as Member; and,

**BE IT FURTHER RESOLVED** that said Board determined that in the absence of the President of the Board of County Commissioners, the Vice President will preside; and,

**WHEREAS** Clerk Leffel then asked that a motion be made to set the hours of regular session for the Board of County Commissioners, Auglaize County, Ohio for 2017; and,

**WHEREAS**, Commissioner Bergman moved that the Board of County Commissioners, Auglaize County, Ohio shall meet as in the past year; same being, in regular session every Tuesday and Thursday from 8:00 a.m. to 4:30 p.m. or until the conclusion of that day's business throughout 2017; Commissioner Spencer seconded the motion; Roll call vote was taken: Mr. Regula - yes; Mr. Spencer - yes; Mr. Bergman - yes. Motion carried.

**THEREFORE BE IT RESOLVED** that the Board of County Commissioners, Auglaize County, Ohio shall be in regular session every Tuesday and Thursday from 8:00 a.m. to 4:30 p.m. or until the conclusion of that day's business throughout 2017; and,

**BE IT FURTHER RESOLVED** that the reorganizational meeting being completed, the session was turned over to President John N. Bergman.
