

IN THE MATTER OF AUTHORIZING EMPLOYMENT OF JASON BELLMANN TO THE POSITION OF PART-TIME TECH SUPPORT POSITION FOR AUGLAIZE COUNTY.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 12th day of March, 2015.

Commissioner Bergman moved the adoption of the following:

RESOLUTION

WHEREAS, Cameron Ruppert, Information Technology Manager, recommended to the Board of County Commissioners the employment of a part-time Tech Support position; and,

WHEREAS, the Board solicited resumes for the position, receiving seven (7) resumes; and,

WHEREAS, five candidates were interviewed for the position by IT Manager, Cameron Ruppert and County Administrator, Erica Preston, and three candidates were interviewed again by the Board of County Commissioners; and,

WHEREAS, after the interviews Mr. Ruppert recommended to the Board that the appointment for the part-time Tech Support position be made to Jason Bellmann; and,

WHEREAS, Mr. Bellmann was contacted about filling the Part-time Tech Support position and he has accepted the position with the effective date of employment being March 17, 2015 with a starting wage of \$16.90 per hour and working on Tuesdays, Wednesdays and Thursdays or as such alternating schedule as may be determined by the Board of County Commissioners with the input from IT Manager Cameron Ruppert and Mr. Bellmann, for a total of approximately 48 hours per bi-weekly pay period; there will be a one hundred and eighty (180) day probationary period.

THEREFORE, BE IT RESOLVED that the Board of Commissioners, Auglaize County, Ohio, does hereby authorize the employment of Jason Bellmann as a part-time Tech Support position as mentioned above; and,

BE IT FURTHER RESOLVED, that the following stipulations apply to this employment:

1. Compensation for Mr. Bellmann will be \$16.90 per hour.
2. There will be a probationary period of 180 days, after probation is satisfactorily served, Mr. Bellmann may receive up to a \$0.34 per hour increase in compensation, as determined by the Board of County Commissioners.
3. Mr. Bellmann has agreed to and signed the position requirements.
4. Mr. Bellmann will be required to work on an as needed basis.
5. Employment to commence on Tuesday, March 17, 2015.
6. Mr. Bellmann will not receive health insurance, vacation days or holiday pay.

WHEREAS, on May 7, 2013, Resolution #13-213, the Board of County Commissioners accepted and entered into a Community Development Block Grant Agreement with the Ohio Development Services Agency for the Residential Public Infrastructure Grant Program on behalf of the Village of Buckland's new sewer facilities project in the amount of \$600,000.00; and,

WHEREAS, on October 17, 2014, Resolution #13-457, the Board of County Commissioners executed a MOU with the Village of Buckland the CDBG F.Y. 2013 Residential Public Infrastructure Improvements contribution will be no more than 21% of the total project costs to VTF Excavation LLC; and,

WHEREAS, the Board of County Commissioners has now been presented with a Contractor's Partial Pay Request #7 in the amount of \$35,665.50 from the CDBG F.Y. 2013 Residential Public Infrastructure Grant from VTF Excavation, LLC through Choice One Engineering Firm and Village of Buckland.
