**WHEREAS**, in Resolution #08-075, the Board of County Commissioners authorized Benchmark Custom Homes Inc. to renovate the County Technology Department to cause the ceiling to be fire proofed and conform to required fire codes; and,

**WHEREAS**, it is necessary to install fire proof registers in said ceiling for the heating and cooling system; and,

**WHEREAS**, quotations for fire proof registers and their installation was requested from Quality Plumbing & Heating, Inc. with the cost for this material and labor being submitted as not to exceed \$1,800.00.
