- 8:00 a.m. Commissioner Spencer moved to approve the resolutions as presented.

  Commissioner Regula seconded the motion. The resolutions were then distributed for each Commissioner's vote and execution.
- 8:16 a.m. Clerk Leffel read the minutes of the May 21st, 2013 meeting. The minutes were approved with some clarification.
- 8:30 a.m. The Board and County Administrator met with Milt Miller to discuss pending legislation on the Joint Lake Facilities Authority for Grand Lake St. Marys. Letters of support for the Lake Facilities Authority were sent to the legislators as proposed.
- 9:30 a.m. Beth Miller and John Smith from the Cooperative Extension Office met with the Board. WDN Reporter Karen Kantner was also present. John Smith stated that 900 people attended the Conservation Tillage Conference, a rain barrel program in Waynesfield Library in June and a plastic recycling program is planned and an upcoming 4-H sea camp. Beth Miller stated that 70 people attended the clothing clinic, working on the rehire of the SNAP Ed position, 95 lambs and 160 goats were weighed in May. Also the Cloverbud Day camp will have a plant theme this year and the 4-H camp is a space theme "Out of this World". The school programs are complete. 1,000 youth are enrolled for 4-H program this year which is up by 15 to 20 participants. Beth also discussed the offices concerns: outside lights are out and could the muffler mart lights be used to help provide additional illumination. Lastly Beth reviewed the budget.
- 10:00 a.m. The Board opened bids for the Gutman #3 Ditch project. Assistant Engineer Kevin Schnell and contractor Bill Gerding were also present.
- 10:10 a.m. The Board and Assistant Engineer Kevin Schnell discussed the contract and bond has not been received from the contractor for the Klosterman Tile Ditch Project and the 10 day period is overdue. The Board decided to award the project to Cy Schwieterman and Clerk Leffel will prepare the resolutions.
- 10:20 a.m. The Commissioners and County Administrator left to attend the Ohio Heritage Awards Luncheon in Columbus, Ohio and to receive an award for the Courthouse Renovation Project.
- 3:30 p.m. Clerk Leffel emailed the resolutions to be considered at the May 28th, 2013 meeting.
