

**IN THE MATTER OF APPROVING A CONTRACT WITH LUCAS COUNTY CORONER FOR AUTOPSY SERVICES; RATIFYING THE EXECUTION OF SAID CONTRACT.**

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 23<sup>rd</sup> day of October, 2014.

Commissioner Regula moved the adoption of the following:

**RESOLUTION**

**WHEREAS**, a contract was presented to the Board of County Commissioners by County Coroner Thomas Freytag from the Lucas County Coroner for autopsy services as requested and needed by Coroner Thomas Freytag; and,

**WHEREAS**, said contract would be effective January 1, 2015 and terminates December 31, 2015 with the fees of \$1,250.00 per autopsy (which includes routine toxicology). Auglaize County would also be responsible for travel reimbursement at the current IRS standard mileage business rate, and be responsible for transporting the body to and from the Lucas County facility. Universal precautions are to be used in transport. Should a body not be in a body bag when received at LCCO, the Auglaize County Coroner's office will be charged \$25.00 for a regular body bag and \$50.00 for an extra large body bag; and,

**WHEREAS**, Coroner Freytag approved the terms of the contract and requested that the Board of County Commissioners, Auglaize County, Ohio, authorize and execute the contract.

**THEREFORE BE IT RESOLVED** that the Board of Auglaize County Commissioners does hereby authorize the contract as presented by the Lucas County Coroner for autopsy services as requested by the Auglaize County Coroner; and,

**BE IT FURTHER RESOLVED** that the Board of County Commissioners, Auglaize County, Ohio does hereby ratify the execution of said contract.

**RESOLUTION**

**WHEREAS**, pursuant to Resolution #518-14 dated September 16, 2014, the Board of Allen County Commissioners adopted a resolution certifying collection assessments for maintenance on various ditches to the Allen and Auglaize County Auditors; and

**WHEREAS**, Resolution #518-14 was accepted and approved by the Auglaize County Commissioners on September 23, 2014; and

**WHEREAS**, R.C. 6137.03 states that “the maintenance assessment shall be made by the Board of County Commissioners in the case of a single county improvement, or by the joint board in the case of a joint county improvement, upon the substantial completion of an improvement and on or before the first day of July in each year thereafter. The assessment shall be certified by the clerk of the board to the county auditor in case of a single county improvement, and to the county auditor of each county interested in the case of a joint county improvement, and shall be placed by the auditor or auditors on the next succeeding tax duplicate to be collected and paid as other special assessment are collected and paid.”; and

**WHEREAS**, after consulting with the Allen County Prosecutor’s Office, it is the recommendation that Resolution #518-14 be rescinded as the certification was made after the July 1 deadline pursuant to RC 6137.03; now therefore

**BE IT RESOLVED THAT THE JOINT BOARDS OF COUNTY COMMISSIONERS OF ALLEN AND AUGLAIZE COUNTY, OHIO**, hereby rescinds Resolution #518-14, certifies collection assessments for maintenance on various ditches to the Allen County and Auglaize County Auditors.
