Due to favorable pricing for this years county highway striping bids, we request permission to add additional centerline striping (\$190.00 mile) and edgelining (\$210.00 mile) resulting in an additional cost of approximately \$14,000.

This will be paid out of 2008 MVGT funds

With the additional) work, a total of 190 miles of County maintained roadways (of the 350 total) will receive a new centerline stripe and 34 miles will be edgelined for a total cost of \$43,240.00
