NOTICE TO ALL CREDITORS, FORMER VENDORS AND FORMER EMPLOYEES

You are hereby notified that, pursuant to proceedings in a lawsuit brought to dissolve entities involved in the case of Paul Mastronardi et al., v. If the documents are not available, you must attach an explanation in detail. Those who do not file timely claims will be barred from recovery from the proceeds.**

Distribution of the assets of the entities will be a final distribution after determination of the validity and priority of all secured, administrative and unsecured claims. Secured and administrative claims will be paid according to their priority, and unsecured claims will be paid pro-rata if there are assets remaining for unsecured creditors, as determined by the court. It is expected that there are not enough proceeds to pay all claims.

Note—The Receiver or any interested person may timely challenge whether a claim is valid, whether the security interest is valid and enforceable, the priority of any secured claim, whether a claim is an administrative claim, and whether the fees, expenses and charges listed are required to be paid, or other pertinent issues, by filing an objection to any claim filed. Such objections must be filed with the Clerk on or before October 2, 2018, and will not be deemed submitted unless and until it is actually file-stamped by the Clerk of this court.
