PY2018 COMMUNITY HOUSING IMPACT & PRESERVATION (CHIP) PROGRAM

The Auglaize County Board of Commissioners intends to apply to the Ohio Development Services Agency (ODSA) for funding of Community Housing Impact & Preservation (CHIP) Program activities under the Community Development Block Grant (CDBG) Small Cities Program and the Federal HOME Investment Partnership Program (HOME), both federally funded programs administered by the State of Ohio. The CHIP Applications are due to the State by May 4, 2018.

On February 12, 2018, Auglaize County conducted the first public hearing to inform citizens about the CDBG program, how it may be used, what activities are eligible, and other program requirements.

A second public hearing will be convened by the Board on Monday, April 23, 2018 at 10:00 a.m., in the Commissioners Chambers located in the Administration Building, 209 South Blackhoof Street, Room 201, Wapakoneta, Ohio 45895 to give citizens an opportunity to provide input on the activities.
