The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 14th day of April, 2011.

Commissioner Spencer moved the adoption of the following:

**RESOLUTION**

**WHEREAS**, the Auglaize County Law Enforcement Center has retained a maintenance contract #2528033010 B, hardware support fees and a software license agreement with CMI on an annual basis; and,

**WHEREAS**, it is necessary, at this time, to renew the CMI software application agreement and the software license agreement with the cost for the Software Implementation/Training being \$21,250.00; the cost of the Hardware Technical Services is \$1,700.00; the cost of Hardware Support is \$531.00, and the cost of the non-Deferred Software Fees is \$15,887.00; and,

**WHEREAS**, the total cost for the deferred payment due January 1, 2012 and for January 1, 2013 for the above mentioned CMI Contract the total cost for Software fees is \$15,888.00 and the cost of Carry Change is \$500.00 each year for 2012 and 2013; and,

**WHEREAS**, said contract renewal was presented to the Board of County Commissioners for its approval and execution.

**THEREFORE, BE IT RESOLVED** that the Board of County Commissioners of Auglaize County, Ohio, does hereby approve the software application contract, hardware support fees and the software license agreement for the Law Enforcement Center with CMI for the amounts so mentioned above, authorizing payment of the annual fee; and,

**BE IT FURTHER RESOLVED** that the Board authorizes John N. Bergman, as President of said Board to execute said contract/agreement renewal.
