The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 14th day of April, 2020.

Commissioner Regula moved the adoption of the following:

**RESOLUTION**

**WHEREAS**, on March 26, 2020 in Resolution #20-137 the Board of County Commissioners, Auglaize County requested from local banks an interest quote for the Shindollar Ditch Project note; and,

**WHEREAS**, the deadline for the interest quote was April 6, 2020 at noon and no quotes were received due to the heavy workload of the local banks during the COVID-19 health crisis; and,

**WHEREAS**, it is necessary, at this time, to re-bid to obtain a note for the balance of money needed to complete the Shindollar county ditch project; and,

**WHEREAS**, the County Engineer's office informed the Board of County Commissioners that the amount remaining as the unpaid balance from the total amounts assessed and the time period for the note is:

**Shindollar Ditch Improvement: Eight (8) semi-annual installments note \$14,483.11.**

**THEREFORE, BE IT RESOLVED** that the Board of County Commissioners, Auglaize County, Ohio does hereby authorize the necessary steps to be taken to rebid with the local banks to secure interest cost for said note for the balance of money needed to complete the above named Ditch improvement project in the amount as mentioned above.

**RESOLUTION**

**WHEREAS**, Section 107 of the Workforce Innovation and Opportunity Act (WIOA) requires each local workforce development area of the State to establish a WDB to administer the functions outlined in section 107 (d) of WIOA for its local workforce development system; and,

**WHEREAS**, the composition requirements of local Workforce Development Board (WDB) must include representatives from four categories: 1) Business, 2) Workforce, 3) Education & Training, and 4) Government and Economic Development; and,

**WHEREAS**, due to retirement of Greg Myers, Dennis Hirt, Workforce Development Board Area 8 Director, recommends the appointment of Logan O'Neill as the representative for Economic Development to the Area 8 Workforce Development Board; Mr. O'Neill will replace Mr. Greg Myers.

**THEREFORE, BE IT RESOLVED** that the Board of Commissioners, Auglaize County, Ohio, does hereby approve the appointment of Logan O'Neill to serve on the Area 8 Workforce Development Board as a representative of the Economic Development.
