- 8:16 a.m. Clerk Leffel presented the minutes of the April 28th, 2020 meeting via email. The presented minutes were unanimously approved by the Board.

  - Stated the Sharlon response letter is ready for the Board's signature.
  - Informed the Board that she has sent out the draft memo to all elected officials and department heads to be discussed later today.
- 8:20 a.m. Clerk Leffel reported the following:
  - Stated that the First Hearing for the Woodland Hills will be changed to a phone conference.
     Doug Reinhart and TJ Place will mail the PowerPoint presentation and notification of the change to the landowners.
  - Stated the Mental Health Board of Allen, Auglaize and Hardin has requested that the Board sign a resolution recognized the month of May of "Mental Health Month". The Board will sign a resolution as they done in the past.

- Stated that for the PY2018 CHIP Grant that the Board will need to commit an additional \$18,797 from the Program Income Fund to complete the six and final private rehab. The Board agreed to commit the additional funds and the Clerk will prepare the resolution for their approval.
- Stated that Shelly Busse from the AMBE has requested that the Board sign 20 under 20 winner certificates for Auglaize County students. The Board instructed the Clerk to prepare the certificates for their approval next week.
- Informed the Board that a CHIP recipient would like to refinance her mortgage and this would require a subordination agreement to be executed by the Board.
