The Contractor agrees to furnish all necessary material, supplies, machinery, equipment, tools, superintendence, labor, insurance and other accessories and services necessary to complete the above described project. Work will commence on or before the 10th day of August, 08, 2018 and complete the project by November 16, 2018. Liquidated damages for this project are \$400.00 for each consecutive day thereafter.
