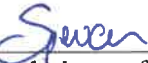
WHEREAS, the total increase for the changes stated is \$7,400.00 for a new total cost of \$844,900.00; and,

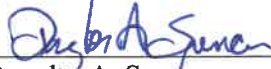
BE IT FURTHER RESOLVED that President of the Board is hereby authorized to execute said Change Order #1 as presented by Westerheide Construction Company.
