## MISCELLANEOUS NOTES TO CONTRACTOR CHRIST HENGSTLER DITCH

ITEM #1 Bids for this particular ditch project shall be opened on Tuesday, March 7th, 2023 at 10:30 a.m. in the Office of the Commissioner's Chambers, Room 203, Auglaize County Administration Building, located at 209 South Blackhoof Street in Wapakoneta, Ohio. All bids submitted shall be enclosed and sealed in an envelope stating, "CHRIST HENGSTLER DITCH BID" on the outside of the envelope.

ITEM #2 A bid bond or certified check in the amount of 10% of your bid shall accompany all bid proposals to guarantee each and every bid proposal submitted to the County Commissioners. All certified checks are to be made payable to the Auditor of Auglaize County. All bid bonds and certified checks shall be released to all unsuccessful bidders within 10 days of the County Commissioners awarding a contract to the winning Contractor.

ITEM #3 The awarded contractor must present either a performance bond, certified check or letter of credit within 10 days of the actual bid opening. The amount of bid bond or certified check shall be the same amount as his bid. The letter of credit shall be in the amount of 125% of his bid. The Auglaize County Engineer shall be the supplier of all letter of credit forms if that bonding choice is made.

ITEM #4 The Board of County Commissioners of Auglaize County reserve the right to waive any or all minor irregularities and reserves the right to accept or reject any or all bids presented to them, as they feel will best serve the interest of Auglaize County. Any or all bids received which have a total bid amount higher than the Engineer's estimate shall automatically be rejected.

ITEM #5 All County Ditch Petition projects (Section 6131, ORC) being let by the Board of County Commissioners of Auglaize County, Ohio, are not required to pay prevailing wage laws as ascertained by the Department of Industrial Relations as per House Bill 350, effective end of June, 1994.

ITEM #6 The awarded Contractor must furnish to the Board of County Commissioners of Auglaize County proof of liability insurance stipulated as follows:

- 1) The limits of liability insurance shall not be less than \$500,000 for bodily injury, property damage, and personal injury.
- 2) The policy shall be comprehensive from including products, completed operations, and contractual liability.
- 3) The limits of liability insurance shall not be less than \$500,000 for bodily injury, property damage, and personal injury.
- 4) The policy shall be comprehensive from including products, completed operations, and contractual liability.
- 5) Auglaize County, the Board of County Commissioners, the County Engineer, etc, shall be named as additional insurance on any subcontractor policy, with the fore mentioned individuals and entities being held harmless from any lawsuits resulting from the performance of the Contract.
- 6) Before any work is started by a Contractor or Subcontractor, a certificate of insurance shall be supplied to, and on file with the Board of County Commissioners of Auglaize County.

ITEM #7 Affirmative Action Clause: Each bidder, contractor or subcontractor must fully comply with all rules, regulations, or restrictions in full as per Executive Order 11246 of the Affirmative Action, non-Discrimination of Employees Law.

ITEM #8 All labor, materials, and installations for the construction of the project shall be completed according to the dates and deadlines as described at the top of page #1 of this bid application. The Contractor will have a TOTAL OF 90 CALENDAR DAYS to complete the Open Ditch and Tile installation starting from the day of the commencement of the construction, to the last day all installed items of the contract are approved and considered completed. Leveling and seeding can be finished at a later date as directed by the Auglaize County Engineers.

There shall be no extensions of contract given to any Contractor who delays the start of construction and does not allow for normal breakdowns or rain out dates and unable to finish the job in item. The awarded Contractor must follow the material and installation specifications as described in the engineering plans.

Failure to complete the project on the scheduled completion date within the specified completion date shall be subject to penalties similar to Section 108.07 of the Ohio Department of Transportation's Bidding and Specifications Manual, said section states in part: "For each calendar day that any work shall remain uncompleted after the contract completion date, the sum specified as follows shall be deducted from any money due the Contractors, not as penalty, but as liquidated damages received." The amount of liquidated damages to be assessed for each calendar day of overrun in time past the contract completion date shall be an amount up to \$250.00 per day as determined by the BOARD OF COUNTY COMMISSIONERS for the purposes of this Contract, and not as the amount specified by the ODOT Bidding and Specifications Manual (which states a rate \$500.00 per day).

Partial payments can be made for pipe delivered on site.

The awarded Contractor shall also make arrangements with the landowner, and/or the farm operator for each specific property directly affected by this project for entry and/or right-of-way access to this project, as well as the delivery of pipe, catch basins, aggregates, etc. Landowner contact information is available by contacting the Auglaize County Engineers Office at 419-739-6520.
