NOTICE TO ALL CREDITORS, FORMER VENDORS AND FORMER EMPLOYEES

You are hereby notified that, pursuant to proceedings in a lawsuit brought to dissolve entities involved in the case of Paul Mastronardi et al., v. Luis Chibante et al., Case No. 2017-CV-144, the assets of both entities have been liquidated, and all those who claim to be creditors of, have any claim against, or interest in, either entity or the proceeds of said liquidation **must file a proof of claim on or before September 18, 2018**, in this court or forever be barred from enforcing any claim against the said entities or the proceeds of the sale of the assets of the entities. The court's Proof of Claim form **must** be used and submitted, and will not be deemed submitted unless and until it is actually file-stamped by the Clerk of this court.

Distribution of the assets of the entities will be a final distribution after determination of the validity and priority of all secured, administrative and unsecured claims. Secured and administrative claims will be paid according to their priority, and unsecured claims will be paid pro-rata if there are assets remaining for unsecured creditors, as determined by the court.
