JOB RESPONSIBILITIES:

Works under the direction of the County Engineer and/or the Deputy Engineer in design, planning, construction, and coordinating departmental office, road and bridge projects. Provides technical, engineering, and surveying advice and assistance to the office, road and bridge supervisors, performs other related duties as required.

JOB DESCRIPTION:

Assists County Engineer and supervisory staff in managing departmental operations and policies. Provides technical engineering and surveying advice and assistance to office, road and bridge supervisors. Responds to citizen concerns and complaints. Resolves project engineering/surveying problems and ensures project work is completed according to established departmental policy, standard operation procedures, State of Ohio codes and standards. Resolves departmental engineering/surveying and project problems in the absence of the County Engineer. Performs engineering design and cost analysis for road, bridge, culvert, and guardrail projects. Submits proposed plan to County Engineer for approval. Inspects roads and bridges for compliance with approved construction plans and specifications. Inspects and/or assists in the inspection of existing bridges as necessary. Review permit applications for gas, telephone, or other utility companies. Prepares bids for various contracting out road and bridge projects. Assists and consults with County Engineer on awarding of bids. Establishes, maintains and updates inventory records of all County Road signs and culverts consisting of date and location of installation. Conducts traffic counts and speed zone studies on County Highways as required. Provides various engineering and technical information to township officials, other public officials, and residents.

QUALIFICATIONS:

Any combination of training and work experience that indicates possession of the skills, knowledge and abilities listed above.

Examples of an acceptable qualification for this position are:

- BSCE Graduate with E.I. Certificate (or ability to achieve) or Registered Professional Engineer in State of Ohio
- Individuals must possess valid Ohio Driver's License
- Capable of lifting and carrying various field instruments for long periods of time over rough or uneven terrain, weighing approximately 60 pounds, and maybe exposed to inclement seasonal weather.
