IN THE MATTER OF REAPPOINTING TOM PIPER AS THE AUGLAIZE COUNTY APIARY INSPECTOR FOR 2009.

The Board of County Commissioners of Auglaize County, Ohio met in _____ session on the 17th day of December, 2008. _____ special

Commissioner KRAMER moved the adoption of the following:

RESOLUTION

WHEREAS, pursuant to the Ohio Revised Code, the Board of County Commissioners may appoint a person to serve as Apiary Inspector for the county; and,

WHEREAS, Mr. Tom Piper has served as the County's Apiary Inspector for the past eight years to the satisfaction of the Board and has expressed his willingness to serve in said position for the 2009 season at the same rate of compensation as last year; same being \$3,450.00; and,

WHEREAS, Mr. Piper requested that he be considered for OPERS benefits through the County as he is approaching retirement through STRS; OPERS contribution to be deducted from his compensation.

NOW, THEREFORE BE IT RESOLVED that the Board of County Commissioners, Auglaize County, Ohio does hereby re-appoint Tom Piper to fill the position of Apiary Inspector for the 2009 season; and,

BE IT FURTHER RESOLVED that compensation for said position be set at \$3,450.00 salary, expenses and mileage reimbursement of fifty and one-half cents (\$.50.5) per mile; and,

BE IT FURTHER RESOLVED that the Clerk of the Board is ordered to complete the necessary forms for the State of Ohio Department of Agriculture to ensure the appointment of Tom Piper as the Auglaize County Apiary Inspector; and,

BE IT STILL FURTHER RESOLVED that the Board of County Commissioners does not approve the request for OPERS participation through the County.
