The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 2nd day of December, 2021.

RESOLUTION

WHEREAS, Auglaize County Department of Job & Family Services has submitted a Memorandum of Understanding which is between Auglaize County Department of Job & Family Services (ACDJFS), 12 N. Wood St., Wapakoneta, OH and the Wings and Support Recovery (Provider), 729 S. Walnut Street, Marysville, OH. The Ohio Attorney General created a pilot program to serve families harmed by parental opioid abuse in Ohio known as the Ohio Sobriety, Treatment, and Reducing Trauma (“Ohio START”) Program; and,

WHEREAS, the MOU is intended to establish a formal working arrangement between ACDJFS and Provider. This MOU is designed to develop and maintain network of services, which meet specific individual needs, builds communities of recovery, and enhances continuity of care; and,

WHEREAS, the initial of this agreement shall commence on last date signed below and shall continue for a period of one (1) year and shall automatically renew for an unlimited number of one (1) periods. During the initial term (or any renewal thereafter) either Party shall have the right to terminate this MOU at any time giving a 60-day written notice.

THEREFORE, BE IT RESOLVED that the Board of Commissioners, Auglaize County, Ohio, does hereby approve and authorize the MOU for the Auglaize County Department of Job and Family Services (ACDJFS) and the Auglaize County Children Services Agency; and,
