IN THE MATTER OF REAPPOINTING TOM PIPER AS THE AUGLAIZE COUNTY APIARY INSPECTOR FOR 2016.

The Board of County Commissioners of Auglaize County, Ohio met in Regular session on the 22nd day of December, 2015.

Commissioner Regula moved the adoption of the following:

RESOLUTION

WHEREAS, pursuant to the Ohio Revised Code, the Board of County Commissioners may appoint a person to serve as Apiary Inspector for the county; and,

WHEREAS, Mr. Tom Piper has served as the County's Apiary Inspector for the past twelve years to the satisfaction of the Board and has expressed his willingness to serve in said position for the 2016 season at the same rate of compensation as last year; same being \$3,450.00.

NOW, THEREFORE BE IT RESOLVED that the Board of County Commissioners, Auglaize County, Ohio does hereby re-appoint Tom Piper to fill the position of Apiary Inspector for the 2016 season; and,

BE IT FURTHER RESOLVED that compensation for said position be set at \$3,450.00 salary, expenses and mileage reimbursement equal to the mileage rate established by the Internal Revenue Service; and,

BE IT FURTHER RESOLVED that the Clerk of the Board is ordered to complete the necessary forms for the State of Ohio Department of Agriculture to ensure the appointment of Tom Piper as the Auglaize County Apiary Inspector.

IN THE MATTER OF AUTHORIZING THE PROMOTION OF JASON BELLMANN TO THE POSITION OF FULL TIME TECH SUPPORT POSITION FOR AUGLAIZE COUNTY.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 22nd day of December, 2015.

Commissioner Regula moved the adoption of the following:

RESOLUTION

WHEREAS, Cameron Ruppert, Information Technology Manager, recommended to the Board of County Commissioners the promotion of Jason Bellmann to a full-time Tech Support position; and,

WHEREAS, the Board agreed with the Information Technology Manager's request; and,

WHEREAS, Mr. Bellmann was contacted about the full-time Tech Support position and accepted with the effective date of full-time employment being December 31, 2015 with a starting wage of \$1,360.00 bi-weekly; there will be a one hundred and eighty (180) day probationary period.

THEREFORE BE IT RESOLVED, that the Board of County Commissioners, Auglaize County, Ohio, does hereby authorize the promotion of Jason Bellmann as the full-time Tech Support position as mentioned above; and,

BE IT FURTHER RESOLVED that the following stipulations apply to the promotion:

1. Compensation for Mr. Bellmann will be \$17.00 per hour.
2. There will be a probationary period of 180 days, after probation is satisfactorily served, Mr. Bellmann may receive up to a \$0.33 per hour increase in compensation, as determined by the Board of County Commissioners.
3. Promotion to commence on Thursday, December 31, 2015.
