THEREFORE, BE IT RESOLVED that the Board of Commissioners, Auglaize County, Ohio, does hereby authorize the employment of Rosa Abel as a part-time janitor/housekeeper as mentioned above; and,

#### BE IT FURTHER RESOLVED, that the following stipulations apply to this employment:

- 1. Compensation for Ms. Abel will be \$10.00 per hour.
- 2. There will be a probationary period of six months, after probation is satisfactorily served, Ms. Abel will receive a \$.95 per hour increase in compensation.
- 3. Ms. Abel has agreed to and signed the position requirements that are attached.
- 4. Ms. Abel will be required to work on an as needed basis.
- 5. Employment to commence on Thursday, January 2, 2014.
- 6. Ms. Abel will not receive health insurance, vacation days or holiday pay.
