IN THE MATTER OF ESTABLISHING NEW FUND NEEDED FOR AUGLAIZE COUNTY FUEL SYSTEM FUND.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 30th day of December, 2025.

Commissioner Spacer moved the adoption of the following:

RESOLUTION

WHEREAS, County Engineer Andrew Baumer requested a new fund be setup for the county fuel system. Currently, the fuel surcharge is reimbursed as a revenue item into MVGT with an expense line item in the MVGT budget as well. In 2025, there was a total of 7,878 transactions at the fuel pumps, with 5,458 of those transactions coming from other county entities. Since 50% of the fuel gallons on 70% of the transactions are from non-Engineer department transactions, this fuel system is the Auglaize County Fuel system, not just the County Engineer. Based on these details, I am proposing a new fund be created to separate this revenue to clearly dedicate funds and account for all expenses of the Auglaize County fuel system. I would further recommend that this fund be interest bearing to help this fund grow;

WHEREAS, MVGT would transfer the current account balance of \$203,518 to establish the fund. All future per-gallon surcharge dollars collected would be paid into this new fund from all County entities, including the County Engineer. All future maintenance expenses would be paid out of this fund. The County engineer will continue to administer, bill, and maintain the system;

WHEREAS, the Board of County Commissioners and the County Auditor have determined that it would be advantageous for Auglaize County to establish the following Fund:

Fuel System Fund;

1. Julie Gossard shall remain a full-time employee of Auglaize County.
2. Auglaize County retains all appointing authority, personnel administration, and employer-of-record responsibilities.
3. This MOU does not create an employment relationship between Hardin County and the Director.

NOW, THEREFORE, BE IT RESOLVED that said Board of County Commissioners hereby agrees to the terms of the Memorandum of Understanding with the Hardin County Commissioners and authorizes the execution of such MOU.
