- Discussed opening an insurance claim for the sprinkler head break due to elevator repair costs and any other potential repairs to the building.
- Reported the asbestos survey will be scheduled for 120 W. Main St., Cridersville. The Board authorized the County Administrator to sign the quote.
- Reported the demo crew is delayed beginning work at the Auglaize Acres site due to inclement weather at their other site.



12:00 p.m. With no further business to bring before the Board, President Bergman adjourned the meeting for the day.




