IN THE MATTER OF AUTHORIZING ADDITIONAL SOLID WASTE EMPLOYEE TO BE PAID OVERTIME.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 12th day of February, 2019.

Commissioner Spencer moved the adoption of the following:

RESOLUTION

WHEREAS, Tyler Varno is employed at the Auglaize County Recycling Center; and,

WHEREAS, Solid Waste District Coordinator, Scott Cisco, has requested to pay the above named individual overtime rather than having them earn compensatory time for a defined period of time in order to keep the facility operating effectively and to complete the sort line project at the recycling facility; and,

WHEREAS, the Board of County Commissioners wishes the above named individual to be paid for the overtime hours worked until the sort line project is completed at the recycling center instead of accumulating compensation time.

THEREFORE, BE IT RESOLVED that the Board of County Commissioners, Auglaize County, Ohio does hereby authorize Tyler Varno, Auglaize County Recycling Center employee, to be paid as overtime hours for all eligible hours worked from February 5, 2019 through the earlier of the conclusion of (1) the sort line project at the recycling facility or (2) April 1, 2019.
