

IN THE MATTER OF DESIGNATING THESE INDIVIDUALS WILLING TO SERVE ON THE COUNTY'S LOCAL EMERGENCY PLANNING COMMITTEE AND PETITIONING THE STATE'S EMERGENCY RESPONSE COMMISSION TO APPOINT THESE INDIVIDUALS PURSUANT TO OHIO REVISED CODE SECTION 3750.03.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 5th day of February, 2026.

Commissioner Bamber moved the adoption of the following:

RESOLUTION

WHEREAS, Auglaize County has been designated by the State's Emergency Response Commission as an emergency planning district; and,

WHEREAS, the purpose of the planning district is to prepare and implement the district chemical emergency response and preparedness plan pursuant to Ohio Revised Code; and,

WHEREAS, the State's Emergency Response Commission shall appoint the members of the planning committee of the district from a list of persons submitted by the Board of County Commissioners; and,

WHEREAS, in resolution number 25-418 dated August 14, 2025, Auglaize County did designate certain individuals to the LEPC Board; and

WHEREAS, Troy Anderson, the EMA Coordinator has indicated that additional individuals are seeking appointment to the LEPC; and

WHEREAS, Mr. Anderson is recommending approval as such individuals meet needed categories of representation; and

WHEREAS, the terms of office of the members recommended shall begin immediately upon approval by the State and shall terminate on August 13, 2027; and;

WHEREAS, the following additional individuals have agreed to serve as members of the Auglaize County Local Emergency Planning Committee:

THEREFORE, BE IT RESOLVED that the Board of County Commissioners, Auglaize County, Ohio, does hereby designate those individuals as listed above as the Auglaize County Local Emergency Planning Committee and respectfully petitions the State's Emergency Response Commission to formally appoint these individuals pursuant to Ohio Revised Code Section 3750.03 with the term of appointment being immediate through August 13, 2027; and,

BE IT FURTHER RESOLVED that the Clerk of the Board be instructed to certify a copy of this Resolution to the State's Emergency Response Commission.
