RESOLUTION

WHEREAS, Rob Egbert, James Ray, Brian Stelzer and Earl Gannon are employed at the Auglaize County Recycling Center; and,

WHEREAS, Solid Waste District Coordinator, Scott Cisco, has requested to pay the above named individuals overtime rather than having them earn compensatory time for a defined period of time in order to keep the facility operating effectively and to complete the sort line project at the recycling facility; and,

WHEREAS, the Board of County Commissioners wishes the above named individuals to be paid for the overtime hours worked until the sort line project is completed at the recycling center instead of accumulating compensation time.
