- WHEREAS**, the health and well-being of congenital heart patients is of paramount importance; and,
- WHEREAS**, each year in the United States, more than 40,000 babies are born with a congenital heart disease; and,
- WHEREAS**, the medical community has identified congenital heart disease as the leading cause of birth defect-related deaths; and,
- WHEREAS**, medical research can provide more identifiable means of the origins and symptoms of congenital heart disease; and,
- WHEREAS**, there is no cure for congenital heart disease, and it is a lifelong disease requiring ongoing specialized care; and,
- WHEREAS**, fewer than 10% of adults with congenital heart disease are receiving recommended care; and,
- WHEREAS**, it is crucial that individuals planning a family, fetal clinicians, obstetric physicians, pediatricians, and all those in the medical field have a greater understanding of the potential for congenital heart disease; and,
- WHEREAS**, Congenital Heart Disease Awareness Week provides the opportunity for patients and families affected by this condition to share their experiences and knowledge, so that the general public may be aware of how this defect affects our lives.
- THEREFORE, BE IT RESOLVED** that the Board of Commissioners, Auglaize County, Ohio, does hereby proclaim the week of February 7 – 14, 2023, as
