

IN THE MATTER OF REORGANIZATION OF THE BOARD OF AUGLAIZE COUNTY COMMISSIONERS FOR THE YEAR 2019.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 14th day of January, 2019.

Commissioner Bergman moved the adoption of the following:

RESOLUTION

WHEREAS, Section 305.05 of the Ohio Revised Code states that the Board of County Commissioners shall organize no later than the second Monday of January of each year; and,

WHEREAS, on Monday, January 14, 2019, at 8:40 a.m., President of the Board Douglas A. Spencer turned the meeting over to Esther Leffel as Clerk of the Board for the reorganization of the Board of County Commissioners of Auglaize County, Ohio; and,

WHEREAS, Clerk Leffel, asked for a motion for nominations for the President of the Board and Vice President of said Board for 2019; Commissioner Spencer made the motion that Don Regula to serve as President of the Board and John N. Bergman to serve as Vice President of said Board for 2019 and Commissioner Bergman seconded the motion. Roll call vote was taken on this motion; Mr. Regula yes, Mr. Spencer yes and Mr. Bergman yes. Motion carried.

THEREFORE BE IT RESOLVED that the Board of County Commissioners of Auglaize County, Ohio, does hereby reorganize for the year of 2019, naming Don Regula to serve as President of the Board; John N. Bergman will serve as Vice President; Douglas A. Spencer will serve as Member; and,

BE IT FURTHER RESOLVED that said Board determined that in the absence of the President of the Board of County Commissioners, the Vice President will preside; and,

WHEREAS Clerk Leffel then asked that a motion be made to set the hours of regular session for the Board of County Commissioners, Auglaize County, Ohio for 2019; and,

WHEREAS, Commissioner Spencer moved that the Board of County Commissioners, Auglaize County, Ohio shall meet as in the past year; same being, in regular session every Tuesday and Thursday from 8:00 a.m. to 4:30 p.m. or until the conclusion of that day's business throughout 2019; Commissioner Bergman seconded the motion; Roll call vote was taken: Mr. Regula yes, Mr. Spencer yes and Mr. Bergman yes. Motion carried.

THEREFORE BE IT RESOLVED that the Board of County Commissioners, Auglaize County, Ohio shall be in regular session every Tuesday and Thursday from 8:00 a.m. to 4:30 p.m. or until the conclusion of that day's business throughout 2019; and,

BE IT FURTHER RESOLVED that the reorganizational meeting being completed, the session was turned over to President Don Regula.

Commissioner Spencer seconded the Resolution and upon the roll being called, the vote resulted in the adoption of the Resolution as follows:
