Whereas, on June 7, 2022, in Resolution #22-279, the Board of County Commissioners approved and executed a Work Order No. 4 to the Master Service Agreement for the Airport Master Plan Update Project; and

WHEREAS, Butler, Fairman and Seufert, Inc. have, at this time, presented to the Board of County Commissioners the Amendment No. 1 to Project Work Order No. 4 to the Master Service Agreement for Professional Services for a total increase amount of \$28,820.00 broke down as follows:

Project Work Order No. 4: Implementation Planning increase of \$5,820.00 (from \$61,100.00 to \$66,920.00); Master Plan Documents increase of \$16,820.00 (from \$118,070.00 to \$134,890.00); and Project Management and Coordination increase of \$6,180.00 (from \$74,720.00 to \$80,900.00).
