The Board of County Commissioners convened in regular session at 8:00 a.m. on Tuesday, January 31, 2012 in the Commissioners Chambers with the following members present: Douglas A. Spencer and John N. Bergman. The meeting of the Board was called to order by President Spencer.

- 8:00 a.m. Commissioner Regula was excused from today's session.
- 8:15 a.m. The Commissioners reviewed and signed the check register as presented by the County Auditor's Office.
- 8:30 a.m. Clerk Leffel read the minutes of the January 24th & 26th, 2012 meetings. The minutes were approved some modifications.
- 8:30 a.m. Commissioner Bergman moved to approve the resolutions as presented.
