GENERAL DESCRIPTION:

Under direction of solid waste management district coordinator and recycling foreman, operates motorized equipment to load and unload materials and to haul recyclables; collects recyclable materials completing assigned recycling routes and collection from community recycling centers and additional facilities within acceptable timeframes, sorts materials and recyclables; controls material litter outside and inside facility; assist public in recycling matters as instructed.

QUALIFICATIONS:

LICENSURE OR CERTIFICATION REQUIREMENTS:

Must possess a valid Ohio driver's license and maintain insurability under the county's vehicle insurance policy; forklift certification (to be obtained within probationary time)

15% (3) Performs routing cleaning on equipment and work area as assigned; troubleshoots problems with equipment; notifies solid waste management district coordinator and/or recycling foreman of any mechanical problems or maintenance issues; sorts materials into appropriate categories for recycling in a safe and expeditious manner (e.g., follows safety rules and regulations, performs daily maintenance checks on equipment used in daily operations to identify maintenance needs and maintain safer operation, etc.)

(4) Maintains required licensures and certifications.

(5) Meets all job safety requirements and all applicable OSHA safety standards that pertain to essential functions.
