WHEREAS, the Board of County Commissioners did receive a grant through the State of Ohio's Comprehensive Housing Improvement Program for the rehabilitation of housing units within the County; and,

WHEREAS, in Resolution #21-163, dated April 20, 2021, the Board approved home repair to the property of Carrie Steinke at a cost of \$2,552.00; and,

WHEREAS, Poggemeyer Design Group Inc. has advised the Board of the need for a change orders #1 and #2, which is for the following reason: Change Order #1 – Revised contract completion date. Change Order #2 – Remove existing natural gas hot water tank and install new 40-gallon natural gas hot water tank. The existing hot water tank is leaking, and it is causing a safety issue. Cost of the Change Orders #1 and #2 is \$1,800.00.

WHEREAS, these change orders will increase the contract for the new cost of \$4,352.00.

THEREFORE, BE IT RESOLVED that the Board of County Commissioners does hereby authorize the above noted change orders #1 and #2 for home repair work for the Carrie Steinke's property.
