RESOLUTION

WHEREAS, a Memorandum of Understanding (this "MOU") was entered into by and between the Auglaize County Fair Board (the "Fair Board"), the Auglaize County Board of Commissioners (the "BOCC"), and the Auglaize County Veterans Services Commissioner ("VSC") on July 22, 2025; and,

WHEREAS, the parties desire to amend certain provisions of the MOU to clarify their respective responsibilities and obligations, and,

WHEREAS, the fourth provision shall be replaced in its entirety as follows: **Individual Veterans may request use of the Pavilion but at a cost determined by the Fair Board, and in which all payment of said cost shall remain with the Fair Board for upkeep and maintenance of the Pavillion, including the LED lighting provided by Trimlight of Indian Lake; and,**

WHEREAS, the signed amendment to the MOU will be part of this resolution.

THEREFORE, BE IT RESOLVED that said Board of County Commissioners hereby agrees to the terms of the First Amendment to Memorandum of Understanding between Fair Board, BOCC and the VSC and ratifies the execution therein.
