The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 15th day of July, 2021.

RESOLUTION

WHEREAS, Auglaize County Juvenile Court Judge Mark Spees has presented a Memorandum of Understanding (MOU) between the Auglaize County Ohio Juvenile Court by and through the Auglaize County Board of Commissioners and the Auglaize County Educational Service Center (ESC) to transfer of funds for student instructional and social services; and,

WHEREAS, the Auglaize County Ohio Juvenile Court agrees to pay the Auglaize County Educational Service Center the sum of \$60,000 made in two payments, one being on or before March 1, 2022 and the second payment on or before June 30, 2022. This fee will cover a credit recovery program for youth on probation who are attending the Opportunity for Youth. Judge Spees approves and recommends that the Board of Auglaize County Commissioners approve and execute said Memorandum of Understanding.
