WHEREAS, Auglaize County Department of Job & Family Services has submitted a Memorandum of Understanding which is between Auglaize County Department of Job & Family Services (ACDJFS), Allen County (DJFS) and Hardin County (DJFS) for the collaborative efforts for treatment foster care to encompass children with a wide range of needs related to behavioral health, physical health, violence and delinquency, educational needs etc. This service also supports the mission to protect children and strengthen families. This mission strive to keep children within the communities they reside in before removal from home, closer to friends, family and service providers know to the children; and,

WHEREAS, This MOU will be effective from July 1, 2025 through June 30, 2027; and,

WHEREAS, The Allen-Auglaize-Hardin County Collaboration agree to contribute to the costs of salary, travel, resources, and benefits for the Treatment Foster Care Worker and/or Treatment Foster Care Program Lead and recruitment efforts. The budget for each SY26 and SFY27 is \$200,000.00. Allen County will cover 50% (\$100,000) and Auglaize County and Hardin County will each contribute 25% (\$50,000/each) for each SFY. For SFY26 and SFY27, this will be covered by an intercountry transfer of SCPA funds in CFIS (County Finance Information System.
