The Board of County Commissioners convened in regular session at 8:00 a.m. on Tuesday, July 21, 2009 with the following members present: Douglas A. Spencer, Don Regula and John N. Bergman. The meeting of the Board was called to order in its Chambers by President Spencer.

- 7:00 a.m. No one attended the Ag Breakfast.
- 8:05 a.m. Clerk Connie Cordonnier read the minutes of the previous Regular Session meeting, being July 16, 2009. The minutes were then approved as read by the President of the Board. Staff meeting was held immediately after the approval of the minutes.
- 8:45 a.m. Commissioner Regula moved to approve the Resolutions as presented. Commissioner Bergman seconded the motion. Resolutions were then distributed for each Commissioner's vote and execution.
- 8:50 a.m. Board signed the weekly check register as presented by the County Auditor.
- 9:00 a.m. Commissioner Bergman spoke with Suzie White of the Veterans Service Office concerning the retirement of Ed Voisard, Veterans Service Commissioner, as the representative for the Board of County Commissioners on the Sources Board. Ms. White indicated that Ron Zenz might be interested in replacing Mr. Voisard as the Co. Commissioners representative to said Board.
- 10:00 a.m. Commissioners participated in the MPRMA & MEBC Insurance Meeting held in the Assembly Room of the Administration Building. As the host county for the meeting, a luncheon was served to those attending the meeting. This was held in the Meeting Room of the Administration Building.
- 2:00 p.m. Board met with Gary Leppla, Fairgrounds Caretaker. Mr. Leppla requested that authorization be given for paid overtime, instead of comp time, for all hours during the fair which he will work above the regular eighty hour bi-weekly pay period. Additional hours are also worked prior to the opening day of the fair, as well as during fair week which runs August 2 August 8, 2009. The Board agreed to pay Mr. Leppla for overtime hours worked in preparation of the fair and during fair week. The dates of July 25 through August 8, 2009 will be designated for payable overtime hours. The Clerk was directed to draft a resolution to this effect.

- 8:10 a.m. Clerk Connie Cordonnier read the minutes of the previous Regular Session meeting, being July 21, 2009. The minutes were then approved by the President of the Board. Staff meeting followed the reading of the minutes.
- 8:30 a.m. Commissioner Bergman moved to approve the Resolution as presented. Commissioner Spencer seconded the motion. Resolution was then distributed for each Commissioner's vote and execution.
- 10:00 a.m. Board phoned Lonnie Wood, Perry County Commissioner, to discuss the energy audit program that Perry County has implemented.
- 11:30 a.m. Board toured the County's rental house at 207 Perry St.
- 1:00 p.m. Board toured the Auglaize County Dog Shelter near New Knoxville.
- 2:45 p.m. Brian Fisher, Computer Operations Manager, met with the Board. Troy Anderson, EMA/HS Director joined the meeting at 2:00 p.m. Discussion was held concerning options available with the County phone system.

STAFF MEETING

- Discussion was held on the matter of the meeting to be held on July 30th between the Commissioners and Bruce Miller of Garmann Miller Architects. Commissioner Spencer emailed Steve Heitz about the Commissioners and Mr. Miller touring the Centennial School from 12:15 to 2:00 p.m. .
