RESOLUTION

WHEREAS, the Airport Support Services position has been vacated at the Neil Armstrong Airport for Auglaize County; and,

WHEREAS, resumes have been received, reviewed and interviews have been given for the Airport Support Services position; and,

WHEREAS, Kevin Schwartz was selected to be offered the position; with Mr. Schwartz agreeing to accept the position.

THEREFORE, BE IT RESOLVED that the Board of Commissioners, Auglaize County, Ohio, does hereby authorize the employment of Kevin Schwartz as the Airport Support Services position as mentioned above; and,

BE IT FURTHER RESOLVED, that the following stipulations apply to this employment:

1. Compensation for Mr. Schwartz will be in the amount of \$15.00 per hour with a probation period of 180 days;
2. After probation is satisfactorily served, Mr. Schwartz may receive a \$.50 per hour increase in compensation;
3. Employment to commence on Monday, August 21, 2017.
