The County agrees to engage Contractor as an independent contractor to perform the work set forth in paragraph (B) of this agreement.

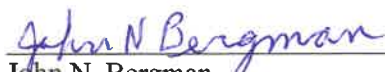
1. The County agrees to engage Contractor as an independent contractor to perform the above mentioned work.

3. This agreement shall end June 30, 2027, unless earlier terminated under the terms of this Agreement.

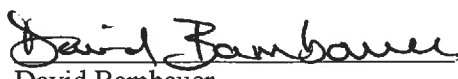
