WHEREAS, Director Julie Gossard recommended that Ms. Myler to be hired for the pilot Child Welfare Fellowship Program on June 4, 2025 at the pay rate per hour of \$15.00. All costs associated with her placement here in Auglaize County will be reimbursed through Wood County's Workforce Innovation and Opportunities Act (WIOA) and Child Abuse Prevention Treatment Act (CAPTA) subawards.

THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Auglaize County, Ohio, does hereby ratify the employment of Zoie Myler to the position so mentioned above in the Auglaize County Department of Job & Family Services; employment in accordance with the specifications as mentioned above.
