**WHEREAS**, the Board of County Commissioners has received notification from the Ohio Department of Development Office of Community Development and proposes to apply for \$500,000 for the PY2024 CDBG Critical Infrastructure (CI) Grant on behalf of the Village of Cridersville; and,
