The Board of County Commissioners convened in regular session at 8:00 a.m. on Thursday, June 18, 2026 in the Commissioners' Chambers with the following members present: John N. Bergman, Douglas A. Spencer, and David Bambauer. The meeting of the Board was called to order by President Bergman.

- 8:00 a.m. Commissioner Bambauer moved to approve the resolutions as presented. Commissioner Spencer seconded the motion. The resolutions were then distributed for each Commissioner's vote and execution.
- 8:24 a.m. Clerk Bobbi Donovan read the minutes of the June 16, 2026 meeting.

- 8:27 a.m. County Administrator Preston presented the following:
  - Reported the CHIP Grant application is entered into Salesforce and ready for submission.
  - Discussed meeting with ODOT to review potential road changes presented with Airport Master Plan alternatives.
  - Discussed a change in fund structure for special projects within the Common Pleas Court and Clerk of Courts.
  - Discussed participation in a biosimilar drug program. The Board recommends opting out of the program at this time.

- 9:15 a.m. The Board and Administrator Preston met with Ryan Miller for the monthly IT update.


#26-268 Matter of authorizing employment of Paison Preston to the position of Intermittent Janitor/Housekeeper for Auglaize County.
