IN THE MATTER OF APPROVING THE CONTRACT BETWEEN AUGLAIZE COUNTY JOB AND FAMILY SERVICES AND WEST OHIO COMMUNITY ACTION PARTNERSHIP (WOCAP) FOR TRANSPORTATION SERVICES FOR MEDICAL NEEDS.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 21st day of June, 2018.

Commissioner Bergman moved the adoption of the following:

RESOLUTION

WHEREAS, it is necessary for the Auglaize County Department of Job & Family Services to contract for transportation services for eligible individuals as determined by said Job & Family Services; and,

WHEREAS, a contract has been negotiated between the Auglaize County Department of Job & Family Services and West Ohio Community Action Partnership (WOCAP) to provide transportation services for medical needs; and,

WHEREAS, contract term to be from July 1, 2018 through June 30, 2019; Cost and delivery of purchased services are subject to the limitations specified in Article 3, reimbursement under this agreement will be fixed unit rate as established by West Ohio Community Action Partnership (WOCAP). "Unit" equals one mile of transportation provided. A unit of service is one mile. WOCAP CTS will charge per mile for NET/EMT Participant per one-way trip. Reimbursements shall be made on a unit cost basis. Transportation for all trips is \$3.20 per mile. All miles are point to point from the first NET/EMT participant pick-up point to the last NET/EMT drop-off point. Miles will be shared cost when two or more participants are being transported. Transportation services will be available in Ohio and Indiana, except for holidays. Holidays will include New Year's Day, Martin Luther King Day, President's Day, Friday before Easter, Memorial Day, Independence Day, Labor Day, Veteran's Day, Thanksgiving, and Christmas Day. Transportation will be provided twenty-four hours a day, seven days a week not to exceed \$250,000.00; and,

WHEREAS, the contract has been approved by the Auglaize County Department of Job & Family Services with the Board of County Commissioners being asked to approve and execute this contract.

THEREFORE, BE IT RESOLVED that the Board of Commissioners, Auglaize County, Ohio does hereby approve the contract between Auglaize County Department of Job & Family Services and West Ohio Community Action Partnership (WOCAP) for transportation services as mentioned above; and,
