IN THE MATTER OF AUTHORIZING INTENT TO ESTABLISH DESIGNATION OF SOLID WASTE FACILITIES PURSUANT TO ORC SECTION 343.014.

The Board of County Commissioners of Auglaize County, Ohio, acting as the Board of Directors for the Auglaize County Solid Waste District, pursuant to Am. Sub. House Bill 197, met in regular session on the 23rd day of June, 2026.

Commissioner  moved the adoption of the following:

RESOLUTION

WHEREAS, the Auglaize Solid Waste Management Plan was approved by the Director of Ohio EPA on March 13, 2026 (the "Plan"); and

WHEREAS, pursuant to Sections 343.01(1)(2), 343.013, 343.014 and 3734.53(E) of the Ohio Revised Code, the Plan authorizes the District Board to designate solid waste facilities to which all solid waste generated within the District must be delivered for transfer or disposal; and

WHEREAS, pursuant to Section 343.014 of the Ohio Revised Code, the Board adopted a resolution of intent to designate solid waste facilities on April 28, 2026 and, on June 2, 2026, the Board conducted a public hearing on said resolution pursuant to notice provided in accordance with Section 343.014; and

WHEREAS, on June 4, 2026 the Board adopted a resolution of preliminary designation approving an Invitation for Designation, standard Designation Agreement, Request for Designation, and related legal notice, for the purpose of identifying solid waste disposal and transfer facilities to which the Board will consider granting final designation pursuant to Sections 343.01 and 343.014 of the Ohio Revised Code; and

WHEREAS, District staff has compiled a list of the solid waste facilities that requested to be designated by the Board in response to the District's published and direct notices, which is included in the list of facilities the Board proposes to designate in the following resolution.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Auglaize County Solid Waste District as follows:

1. Pursuant to Section 343.014(E) of the Ohio Revised Code, the Board hereby declares its intention to establish designation of the solid waste facilities listed in Attachment A hereto as the only solid waste disposal or transfer facilities authorized to receive solid waste generated within the District.
2. The Board shall receive written comments from the public concerning this Resolution of Intent to Establish Designation from July 1, 2026 until 3:00 p.m. July 24, 2026 at the Auglaize County District offices located at 15502 St Marys River Rd. PO Box 603, St Marys, OH 45885; and

3. The Board shall cause public notice of the adoption of this Resolution of intent to Establish Designation, the location where said Resolution is available for review, and the dates when the public comment period begins and ends, in newspapers of general circulation within the Authority; and
4. The Board shall mail notice and a copy of this Resolution of Intent to Establish Designation to:
 - a. fifty industrial, commercial, and institutional generators of solid wastes within the District that generate the largest quantities of solid wastes, as determined by the Board, and to their local trade associations;
 - b. the legislative authority of each municipal corporation and township within the District: and
 - c. the Director of Ohio EPA; and
5. The Board determines this Resolution was adopted at an open meeting conducted in accordance with Ohio's Sunshine Law, Section 121.22 of the Ohio Revised Code as modified by Am. Sub. House Bill 197.

Commissioner Spencer seconded the Resolution and upon the roll being called, the vote resulted in the adoption of the Resolution as follows:
