- Updated the Board on the employee count of getting their wellness check.
- Spoke with Anna Koenig, potential County Library Board representative, who is no longer an Auglaize County Resident. The Board will continue to search for a representative who is a county resident.
- She informed the Board that she is assisting the Fairground Manager with the bidding process for the New Show Barn Project.
- Was contacted by Andy Crump, Trupointe representative, concerning the vacation of an alley or street procedure.
- Darryl Kinstle has asked for an extension for tree top removal from the County owned woods. The Board will view the woods this Thursday and come to a decision.
