

**IN THE MATTER OF APPROVING NOMINATIONS TO THE DANGEROUS WILD ANIMAL RESPONSE TEAM (DWART) FOR AUGLAIZE COUNTY FOR THE THREE YEAR TERM FROM JULY 1, 2016 THROUGH JUNE 30, 2019.**

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 30th day of June, 2016.

Commissioner Spicer moved the adoption of the following:

**RESOLUTION**

**WHEREAS**, the Ohio Revised Code §935.28 requires Dangerous Wild Animal Response Teams (DWART) to be formed in each county; the State of Ohio Dangerous Wild Animal Emergency Response Commission (DWAERC) is charged with approving these county teams; and,

**WHEREAS**, the statute requires that DWARTs be comprised of at least one representative from each of the following local disciplines: Law Enforcement, Fire, First Aid, Emergency Management, Health, Broadcast and Print Media, Elected Local Official, and Dangerous Wild Animal Owner; and,

**WHEREAS**, DWART membership is not limited to the disciplines listed above; State of Ohio Dangerous Wild Animal Emergency Response Commission requests counties to also consider adding a representative for Veterinarian and Public Health; and,

**WHEREAS**, membership to DWARTs is not to exceed three years with an effective date of July 1, 2016 through June 30, 2019; and,

**WHEREAS**, the Board of County Commissioners is to approve the nominees for appointment to the Dangerous Wild Animal Response Team (DWART); the following nominations have been presented for said purpose:

**WHEREAS**, with the position of the GIS Administrator for the Board of Auglaize County Commissioners being vacated, effective April 15, 2016, the Board gave advertisement for interested parties to submit a cover letter, resume and a completed application for employment for said position; and,

**WHEREAS**, the GIS Administrator position is responsible for management and maintenance of county GIS data layers, GIS applications, and GIS management software; designs, implements, and maintains all facet of county GIS data, including the layers, tables, and system interfaces; recommends hardware, software, services and applications to be used; and,

**WHEREAS**, the Commissioners, County Administrator, County Engineer and IT Manager reviewed all resumes as received and performed interviews of selected candidates; and,

**WHEREAS**, Mr. Marok was contacted about the GIS Administrator position and accepted with the effective date of full-time employment being July 5, 2016 with a starting wage of \$2,000.00 bi-weekly; there will be a one hundred and eighty (180) day probationary period.

**THEREFORE BE IT RESOLVED**, that the Board of County Commissioners, Auglaize County, Ohio, does hereby authorize the promotion of James Marok as the GIS Administrator position as mentioned above; and,
