MOVING PERMIT

1. A \$500 certified or cashiers check will be required **if** any mailboxes need removed, road signs reset, or trees need trimmed. This will be returned upon satisfaction of completion of the job.

2. The mover shall at all times, while the structure is upon said roads:
 - Comply with all state laws and local regulations affecting the moving of structures and affecting the safety of the public.
 - Accomplish the moving in such a manner as it least obstructs vehicular traffic.
 - Provide flag person, warning signs, reflectors, lanterns, and other safety devices to the satisfaction of the County Engineer, State, and local laws.
 - Alterations and moving of electric and telephone lines that the mover may determine to interfere with the moving will be done by the utility company involved. The mover shall make his own arrangements in advance of the actual moving with the utility company concerned for such alterations. If telephone and/or power lines have to be disconnected, the mover is to notify all people who will be temporarily out of service (24 hours before the move begins).
 - All signs will be reinstalled by the County (for liability reasons) and the mover will be billed for this from the County (estimates available from the Engineer's Office).
 - Any mailboxes removed will be reinstalled by the mover and will be in as good or better condition than they found them. Failure to do so will result in a \$25 mailbox penalty reimbursable to the property owner.
 - Any tree trimming shall have the written permission from the property owner and all branches and debris will be cleaned up by the mover. Failure to do so will result in a \$25 tree charge reimbursable to the property owner.
 - If the road will be closed for **any** reason, the mover will be charged \$500 per night while the road is closed.
 - The mover shall contract the Sheriff's Office before the move so they will know the route that will be blocked for fire and rescue services.
 - No expense whatsoever shall be assumed or incurred by Auglaize County nor the County Engineer by the granting of this permit.
 - The mover shall be liable for any and all damages to persons and property arising from the mover's negligence and the mover shall indemnify the County and the County engineer from all claims, suits, and damages, due to any act or omission of the mover.
 - The mover will be liable for any and all damages to county roadway, berms, bridges or any county property arising from the move.
 - This permit does not apply to the roads of the State, Township or private property.
 - The County retains the right to bill the mover for any of the above violations and damages over and above any required deposit.
 - Paid deposit of \$ _____ will be returned to the mover (less deductions for damages) within 30 days after completion of the move.
