

IN THE MATTER OF FIXING DATE AND TIME FOR A PUBLIC HEARING FOR THE REICHELDERFER #2 DITCH AND TO REEVALUATE THE MAINTENANCE BASE AND TO UPDATE THE WATERSHED MAP ON SAID DITCH PROJECT.

The Board of County Commissioners of Auglaize County, Ohio met in regular session on the 12th day of March, 2019.

Commissioner Spencer moved the adoption of the following:

RESOLUTION

WHEREAS, Drainage Technician TJ Place presented the following correspondence to the Board on February 21, 2019:

In 2005, the Reichelderfer #2 Ditch subsurface tile was petitioned through Auglaize Soil and Water Conservation District, the new tile has been maintained by the Auglaize County Highway Department. The common watershed boundary matched the Reichelderfer #1 open ditch (constructed in 1968). Because the Reichelderfer #1 watershed has been updated, using modern topographical data the same updates have been made to boundaries of the Reichelderfer #2. Adjusting these boundaries change the acres drained for several parcels and that requires the base assessment to be adjusted for the Reichelderfer #2 tile project.

Section 6137 of the Ohio Revised Code allows for us to review such projects and adjust the base assessments of each parcel for any future maintenance charges. After updating the watershed, the acres drained for each parcel were also adjusted. The construction base cost for the project will be reduced from \$19,810.51 to \$16,166.78. The re-evaluation also has taken into account any new parcel splits and residences built in the watershed over the past 10 years. After the acres drained were updated, the total based cost was redistributed to each parcel using the rate per acre that was used in 2005 for that parcel. Some parcels now have more acres drained and some have fewer acres drained. After the corrections were made to the watershed boundary, a net of 38.61 acres were deleted from the watershed.

This department has prepared an assessment base for the property owners within the Reichelderfer #2 watershed and we are asking the Commissioners to set a date, time and location for the purpose of holding a maintenance hearing as outlined in Section 6137 of the Ohio Revised Code. This department will prepare and mail the notices to the property owners within the watershed.

THEREFORE BE IT RESOLVED, the Board of County Commissioners, of Auglaize County, Ohio does hereby set April 30, 2019 at 1:00 p.m. in the Assembly Room – 2nd Floor in the Administration Building, located 209 S. Blackhoof Street, Wapakoneta, Ohio for the Public Hearing on the reevaluation of the Reichelderfer #2 Ditch watershed map and maintenance base.
